In terms of provision under Section 9 of Himachal Pradesh Technical University Act, 2014 and pursuant to the recommendations of Expert Visit Committee/Inspection Committee constituted for the purpose and the powers vested in him, the Vice Chancellor of this University under Section 13 (7) of Himachal Pradesh Technical University Act, 2014 is hereby granted provisional affiliation to **Atal Bihari Vajpayee Govt. Engineering Institute of Technology, Pragtinagar, Distt. Shimla (HP)** for conduct of following course with intake indicated below for the academic year 2015-2016:

The affiliation is subject to completion of the following deficiencies in the Institution/college pointed out by the Expert Visit Committee/Inspection Committee in their report/ recommendations. You are required to submit compliance report along with documentary evidence of following discrepancies within a period of three months from the issuance of this letter, failing which a penalty of Rs. 50,000/- will be charged. In case, of failure thereof, the process of disaffiliation will be started by the University from the next academic session:-

i. *Proper Cadre ratio of Faculty & staff as per AICTE norms are required.*

The above mentioned approval is further subject to conditions that:

- No excess admissions shall be made by the Institution over and above the approval of intake by the AICTE under any circumstances;

- b) the institution shall not allow closure of the Institution or discontinuation of the course(s) or start new course(s) or alter intake capacity of seats without prior approval of the AICTE;
- c) that the tuition and other fees shall be charged as prescribed by the Govt. of Himachal Pradesh / HP Technical University from time to time. No capitation fee, other charges, fine or Industrial training fee etc shall be charged from the students/guardians of students in any form. In case, any institution found charging any amount other than the prescribed by the Govt. of H.P/ HimTU, shall be de-affiliated.
- d) the institution shall comply strictly with the provisions made under the Anti Ragging Regulation notified by the UGC/AICTE/State Government for prevention and prohibition of ragging in Institution/College. In case Institution fails to take adequate steps to prevent ragging or fails to act in accordance with AICTE Regulation or fails to punish perpetrators of incidents of ragging it will be liable to any action as defined under the provisions of the Act/Regulation; and
- e) the institute will follow the admission procedure, syllabus, examinations procedure and other norms/standards as laid down by the AICTE/Himachal Pradesh Technical University, Hamirpur.
